5. Draft Decree amending Decree No 377/2016 on requirements for the safe management of radioactive waste and on the decommissioning of nuclear installations or category III or IV workplaces

8. The Decree on requirements for the safe management of radioactive waste and on the decommissioning of nuclear installations or category III or IV workplaces regulates:

- a) technical requirements for equipment for workplaces managing radioactive waste;
- b) the procedure for the collection, sorting, processing, treatment, storage and disposal of radioactive waste,
- c) the manner in which a radioactive waste repository is sealed;
- d) requirements regarding the contents of documentation for a permit for the management of radioactive waste and the individual stages of decommissioning of nuclear installations or category III or category IV workplaces;
- e) the scope and method of keeping records of radioactive waste and the accompanying sheet for radioactive waste;
- f) the scope of and method for decommissioning and completing the decommissioning of a nuclear installation;
- g) the scope of and method for decommissioning category III or category IV workplaces
- h) the scope and method of completion of the decommissioning of category III or category IV workplaces.

The draft of the new Atomic Act includes the mutual recognition clause.

9. In relation to the amendment to the Atomic Act (notification 2024/0259/CZ), an analysis of the suitability and necessity of amending legislation implementing the Atomic Act was carried out. For Decree No 377/2016, it was found that the current legislation did not fully take into account the requirements of international documents, namely the WENRA Safety Reference Levels, the WGWD Working Group on Waste and Decommissioning, and the IAEA GSR Safety Standard Part 5, Pre-disposal Management of Radioactive Waste. The proposed legislation eliminates this inconsistency and at the same time takes into account practical experience from SÚJB's supervisory activities concerning holders of radioactive waste management permits. The proposed amendments to the text of the Decree are also intended to facilitate more technical solutions to selected problems in radioactive waste management and decommissioning and address the further need for formal and substantive amendments to the original text of the Decree. The draft decree builds on the experience gained in the application of this decree as part of SÚJB's control activities and on developments at the international level in this area. It does not foresee an increase in administrative or financial burden compared to the current situation, and no other negative impacts are expected.

The basic legislation – Act No 263/2016 – was attached as part of notification 2016/0259/CZ.
Decree No 377/2016, which is being changed by the amendment, was notified under number 2016/0202/CZ.
