5. Draft Act amending Act No 64/2019 on the making available on the market of firearms and ammunition for

civilian use, as amended

6. marking the barrel of a firearm and the cylinder of a revolver with the calibre

The draft Act amending Act No 64/2019 on the making available on the market of firearms and ammunition for civilian use, as amended (the 'draft Act'), lays down requirements relating to marking the barrel of a firearm and the cylinder of a revolver with the calibre and transposes into Slovak law the provisions of Commission Implementing Directive (EU) 2024/325 of 19 January 2024 amending Implementing Directive (EU) 2019/68 as regards the minimum depth of marking of firearms and essential components (hereinafter 'Commission Implementing Directive (EU) 2024/325').

9. Application practice has shown that it is not necessary to mark all essential components of a firearm with the calibre in order to ensure the safety and security of the user of the firearm, and therefore the provisions concerning the marking of a firearm and its essential component with the calibre have been amended.

The provision under point (n) of Article I(2) of the draft Act, which stipulates that only a firearm barrel or a revolver cylinder shall be marked with the firearm calibre, or if the firearm has barrels of different calibres or revolver cylinders of different calibres, each firearm barrel or revolver cylinder shall be marked with the appropriate firearm calibre, is submitted for notification. This modification is without prejudice to the transposition of Article 4(1) and (2) of Directive (EU) 2021/555 of the European Parliament and of the Council of 24 March 2021 on the control of the acquisition and possession of weapons.

The provisions of Article I(2)(o) of the draft Act transpose Commission Implementing Directive (EU) 2024/325.

As a technical annex, we attach a consolidated version of Act No 64/2019 on the making available on the market of firearms and ammunition for civilian use, as amended, with changes highlighted.
