The WTO Committee on Technical Barriers to Trade (TBT) recorded some remarkable achievements in 2024. A Ministerial Declaration on TBT adopted at the 13th Ministerial Conference in Abu Dhabi confirmed members' commitment to regulatory cooperation and transparency and to reducing technical barriers to trade. The Committee also adopted two sets of guidelines on enhancing transparency on TBT matters and on conformity assessment procedures.

In addition, members adopted a comprehensive three-year work programme on standards and regulations, focusing on areas such as deepening discussions on artificial intelligence and critical emerging technologies, agriculture, environment, health, and development.



Standards and regulations play a crucial role in addressing public interests, such as health and environmental protection. By ensuring their transparency and interoperability, we maximize their effectiveness while preventing them from becoming unnecessary barriers to trade.

By facilitating international regulatory cooperation and the active involvement of regulators, trade officials, experts and standardization bodies, the TBT Committee fosters trust across supply chains and supports sound trade policy-making.

It is an honour to chair the TBT Committee, which is a model of progress, innovation, transparency and cooperation on trade issues, both inside and outside this organization. I commend the work of my predecessors and our dedicated Secretariat for their expertise and commitment to advancing the work of the Committee.

MC13 Declaration on Regulatory Cooperation

At the WTO's 13th Ministerial Conference (MC13) in Abu Dhabi in February 2024, WTO members emphasized the TBT Committee's key role in fostering regulatory cooperation to reduce technical barriers to trade. The Declaration, the first in the area of TBT, highlights the importance of dialogue and early engagement on standards and regulations to address challenges in climate change, human health, and the digital economy. It also underlines the important role of digital tools like ePing and eAgenda to promote regulatory convergence and prevent trade friction.





Adoption of the 10th Triennial Review

At its November meeting, the TBT Committee adopted the 10th Triennial Review report, which takes stock of the main achievements of the Committee over the past three years and presents a work programme for the next threeyear cycle. Members agreed to take forward more than 40 specific recommendations, including the organization of 23 thematic sessions covering topics such as critical and emerging technologies, decarbonization standards, additive manufacturing, inter-operable data standards, lithium-ion batteries and medical devices. They also agreed to take steps to further improve Committee practices, transparency procedures and digital tools.





Conformity Assessment Procedure guidelines

Members adopted voluntary guidelines on conformity assessment procedures aimed at helping regulators to develop or adopt appropriate procedures for determining whether products fulfil the requirements established by relevant technical regulations or standards. The objective is to ensure that measures to verify compliance do not create unnecessary obstacles to international trade. The guidelines help to enhance trust between different regulatory systems and facilitate the acceptance of conformity assessment results. They cover topics such as risk, market surveillance, and the use of international standards.

Guidelines on certification adopted by the TBT Commitee

What happened

In March 2024, the Committe on Technical Barriers to Trade adopted guidelines to help governments better choose and design their conformity assessment procedures (CAPs), ensuring products comply with safety and other specifications in standards and regulations without creating unnecessary trade obstacles.

What are the guidelines?

- Focus on risk management, market surveillance, and international standards.
- Emphasize flexibility, transparency and inclusivity with special consideration to the technical assistance needs of developing economies.
- Non-prescriptive and voluntary.



Procedures like certification or testing used to determine if a product meets requirements. For example, quality or safety requirement of a bicycle helmet, or certification of organic foods.

CAPs build trust between exporters, importers, authorities and consumers.

- Ensure that products meet specifications set out in regulations or standards.
- Help regulators make better choices in situations where risks vary.



Transparency Working Group

The TBT Committee's Transparency Working Group helped accelerate improvements to transparency practices by finalizing a practical guide on how to provide comments on draft regulations notified by members. It also took the lead in the development of guidelines for members to follow when communicating the overarching legal and institutional arrangements they have put in place to implement the TBT Agreement, such as where final regulations are published, who can be contacted with enquiries, etc.





Notifications on product requirements

WTO members submitted more than 4,300 notifications on product requirements in 2024, the highest annual total since 1995. Notifications are a form of advance notice, providing an opportunity for the WTO membership to comment on draft measures affecting trade in goods before they enter into force. Typically, notifications concern health or safety requirements or protection of the environment.

Submission of notifications

A total of 91 members (over half of the WTO membership) submitted at least one notification in 2024. Most new notifications (86%) were submitted by developing and least-developed country members.

ePing's global reach

ePing subscribers from 193 countries/territories received customized email alerts, enabling them to monitor and respond to potential regulatory changes affecting their products or markets of interest. These alerts provide a summary of WTO member notifications, outlining the covered products and comment deadlines, along with hyperlinks to further details.





Specific Trade Concerns (STCs)

The number of trade concerns raised at the TBT Committee has decreased annually by an average of 9% since 2021. Members have also reported growing progress in resolving these concerns. In 2024, progress was reported in resolving 10 STCs. Discussing concerns before a measure enters into force often helps prevent escalation into formal disputes. Most concerns arise in response to members' notifications. They range from requests for clarification to potential inconsistencies with the TBT Agreement.

Technical assistance

With 23 national and regional TBT-specific technical assistance (TA) activities successfully organized in 2024, the year marked a return to pre-COVID-19 TA-delivery levels. At MC13, members adopted a Ministerial Declaration stressing the importance of improving capacity building for developing members and the implementation of special and differential treatment for these economies.
