Subject: Notification on the Implementation of the Indonesian Quarantine Authority Regulation Number 14 of 2024

Dear Sir/Madam,

Warm greetings from the Indonesian Quarantine Authority.

We would like to inform you that the Indonesian Quarantine Authority has officially enacted the Indonesian Quarantine Authority Regulation Number 14 of 2024 concerning Procedures for Quarantine Measures and Integrated Supervision. In relation to the implementation of this regulation, particularly Articles 13, 14, and 15, we respectfully convey the following information:

- 1. The competent authority in the country of origin is required to submit the name of the authorized signatory, the specimen signature, and the specimen of the animal health certificate and/or the sanitary certificate for animal products to the Head of the Indonesian Quarantine Authority.
- 2. In addition, we kindly request information regarding the name of the competent authority in the country of origin responsible for issuing the animal health certificate and the sanitary certificate for animal products.
- 3. The submission of specimens, as referred to in point 1, is encouraged to be carried out through mutual agreement between both countries.
- 4. Furthermore, in the event of any changes to the name of the signatory, specimen signature, or certificate specimens after their submission, the competent authority in the country of origin must notify the Head of the Indonesian Quarantine Authority no later than thirty (30) days prior to its intended use.
- 5. Please note that this regulation will come into effect six (6) months from the date of its promulgation, starting on December 4, 2024.
