The Belgian Royal Decree on jam (“KB confituur”) has been revised to align with Directive (EU) 2024/1438, which updates the original Council Directive 2001/113/EC on fruit jams, jellies, marmalades, and sweetened chestnut purée. The original national legislation was not previously submitted through the EU’s Technical Regulation Information System portal, hereby.

9. The Belgian Royal Decree on jam (“KB confituur”) has been updated to comply with Directive (EU) 2024/1438, which amends the original Council Directive 2001/113/EC concerning fruit jams, jellies, marmalades, and sweetened chestnut purée. This revision is notified because the original national legislation had never been submitted through the EU Technical Regulation Information System (TRIS) portal. The legislation includes a specific category for fruit syrups, which has been part of the national framework since the first transposition of the Directive 2001/113/EC and remains outside the scope of the EU directive.
