framework of the Inter-branch Association of the Fresh Fruit and Vegetable Industry
(INTERFEL)
concerning the packaging of plums

Having regard to Regulation (EU) No 1308/2013 of the European Parliament and of the Council of 17 December 2013 establishing a common organisation of the markets in agricultural products;

Having regard to the Rural and Maritime Fisheries Code, in particular Articles L632-1 to L632-11 thereof;

Having regard to Decree No 2014-572 of 2 June 2014 on the recognition of inter-branch organisations;

Having regard to Decree No 2015-226 of 26 February 2015 on procedures for the extension of agreements concluded by agricultural inter-branch organisations;

Having regard to the Order of 26 February 2015 concerning applications for the extension of agreements concluded within the framework of a recognised inter-branch organisation;

Having regard to the Order of 5 July 1976 recognising INTERFEL as an inter-branch organisation;

Having regard to the extract from the minutes of the Conference of National Professional Organisations of 24 March 2026;

Having regard to the inter-branch agreement concluded on 24 March 2026 by the trade organisations forming INTERFEL concerning the packaging of plums;

Hereby order:

Article 1

The inter-branch agreement concluded on 24 March 2026 by the member organisations of INTERFEL concerning the packaging of plums is extended to all members of the trades comprising this inter-trade organisation from 1 June 2026 until 30 May 2029.
