to more environmentally and economically viable construction. Although various binders are introduced into the environment through treatment, when used appropriately, the positive impacts of such use far outweigh any potential adverse impacts. Lime, hydraulic binders and binders with pozzolanic properties are considered as binders in this technical specification. It does not address other binders. The technical specification addresses the installation of binders, quality requirements, measurement and acceptance of works.
