5. Decree of the Ministry of the Environment amending the Decree on the type approval of fittings for PE

pipes for water and sewage systems in buildings

6. Fittings for PE pipes intended for the conveyance of pressurised drinking water and sewage in buildings and properties

The Decree lays down the requirements for the type approval of fittings for PE pipes for water and sewerage systems intended for the conveyance of pressurised drinking water and sewage in buildings and properties. The provisions of the existing Decree (2/20) concerning suitability for conveying drinking water are repealed. In other respects, no changes are made to the Decree.

9. The new EU Drinking Water Directive (EU) 2020/2184 and its hygiene requirements have been implemented through legislation of the Ministry of Social Affairs and Health. The overlapping provisions in the legislation of the Ministry of the Environment must be repealed.
