5. Decree of the Ministry of the Environment amending the Decree on the type approval of PEX pipes for

water installations in buildings

6. PEX pipes intended for conveying drinking water and hot domestic water in the water supply systems in buildings and on properties

The Decree lays down the requirements for the type-approval of PEX pipes of water supply systems intended for conveying drinking water and hot domestic water located in buildings and on properties. The provisions of the existing Decree (1/18) concerning suitability for conveying drinking water are repealed. In other respects, no changes are made to the Decree.

9. The new EU Drinking Water Directive (EU) 2020/2184 and its hygiene requirements have been implemented through legislation of the Ministry of Social Affairs and Health. The overlapping provisions in the legislation of the Ministry of the Environment must be repealed.
