5. Project royal decree amending parts of Books 1 and 2, introduced by the royal decree of 8 September 2019 establishing Books 1, 2 and 3 of the General Regulations on equipment

6. Minimum safety measures for equipment in Belgium in accordance with the General Regulations on equipment (RGIE) introduced by the Royal Decree of 8 September 2019 establishing Books 1, 2 and 3

8. Currently, the RGIE is mainly focused on alternating current equipment. Given the increasing presence of direct current systems in equipment (accumulator batteries, photovoltaic panels, etc.), the objective of the aforementioned project is the:

- Addition of the earthed direct current (TN, TT and IT) diagrams that determine the specification of equipment:
 - Compression of these diagrams;
 - Active protective measures against indirect contact electric shock for these diagrams;
 - Impact on alternating current grounded diagrams;
- Consideration of the impact of the diagrams earthed with direct current in Book 1 (general definitions, other protection measures, selection and use of electrical equipment, etc.);
- Integration of the new project terminology into Books 1 and 2 and editorial verification of the existing parts of Book 1 that have been discussed with the project.

9. On 1 June 2020, a new, restructured RGIE entered into force for equipment implemented in Belgium, replacing the former RGIE in force in Belgium since 1981. The project Royal Decree is part of the ongoing restructuring of the RGIE and its contents to maintain a satisfactory level of safety for people and property in the light of the continuing technological development of equipment.
