5. Order amending the Order on Building Regulations 2018

6. The regulation affects construction and, indirectly, construction products.

8. The Danish Government wants to reduce the climate impact of the construction sector. Therefore, in January 2023, the government introduced an obligation to document the climate impact of new constructions. In addition, some major constructions must keep the climate impact below a limit value.

A newly notified regulation supplements the regulations introduced at the time. However, this newly introduced regulation contained an error two places in the data set. Therefore, that part of the regulation is notified again with a view to correcting the errors.

9. The notified regulation, which is an addition to existing rules on construction, aims to correct previous rules on which data values should be used in the calculation.

The regulation still does not take into account the country in which the construction products used were produced. The regulation does not require a declaration of the climate impact of the construction product. Furthermore, no labelling of products or requirements for labelling of products are introduced.

#### 15. Impact analysis

The draft does not entail any commercial consequences, as only two lines of Table 7 are corrected.
