8. In Flanders, buildings where farm animals are to be housed have to be built under certain conditions and in a manner that ensures low emissions.

A list of low-ammonia-emission farm animal housing systems has been drawn up for this purpose.

A new animal housing system is added to this list in the present draft decision.

9. Low-ammonia-emission farm animal housing systems reduce the amount of ammonia that evaporates from a farm building. These systems also often have an effect on the odour and particulate matter emissions from farm animal buildings.

Flanders is making significant efforts to reduce ammonia emissions by the agricultural sector.

Low-ammonia-emission farm animal housing systems, which work correctly and are very efficient in terms of removal in this regard, are essential.

Newly developed systems should then be incorporated into the legislation. These new systems are based on the very latest developments. The inclusion of a new system increases the options for farmers and also stimulates the development of more new systems.
