5. Draft amendment to Order No 3D-351 of 20 May 2022 of the Minister of Agriculture of the Republic of Lithuania 'On approval of the rules of the National Food Quality System and recognition of some orders of the Minister of Agriculture as invalid'

6. Products manufactured under the National Food Quality System and the certification thereof.

In order to clarify the quality requirements for fruits and vegetables grown in containers in accordance with Annex 6 to the rules of the National Food Quality System (i.e. products manufactured under the National Food Quality System; hereinafter – 'NQP'), the maximum permissible nitrate values have been established for cucumbers and tomatoes grown in containers, and other indicators have been regulated for assessing whether products can be labelled with the 'Quality' mark.

The title of Annex 2 to the NQP rules and the individual provisions thereof have also been revised in accordance with the wording used in subparagraph 11.2 of the NQP rules and item 1 of Annex 2. A reference to the current regulation of animal treatment records has been added to item 12 of Annex 3 and item 7 of Annex 5. Subparagraph 7.2 of Annex 7 has also been revised by adding a reference to the current regulation.

9. For several years, members of the Lithuanian Greenhouse Association have been actively testing various vegetable varieties suitable for our climate, emphasising that they could certify significant quantities of the products they grow in accordance with the requirements of the rules of the National Food Quality System (i.e. products manufactured under the National Food Quality System; hereinafter – 'NQP') and be eligible for the 'Quality' mark, but this would require revising the additional quality requirements for fruits and vegetables grown in containers. Currently, Annex 6 to the NQP rules distinguishes between the special requirements for the primary production of cultivation in containers and in ground, but the additional requirements for labelling products with the 'Quality' mark are presented in general for both container and in-ground systems.
