5. Decree amending Decree No 397/2021 on requirements for preserved fruit and preserved vegetables, nuts, mushrooms, potatoes and their products and bananas

8. Submission of a draft amendment to Decree No 397/2021 The draft Decree is a measure implementing Act No 110/1997 on foodstuffs and tobacco products and amending certain related acts, as amended, and will replace the existing Decree No 329/1997, which implements § 18(a), (b), (e), (f), (g) and (h) of Act No 110/1997 on foodstuffs and tobacco products and amending certain related acts with regard to preserved fruit, preserved vegetables, nuts, mushrooms, potatoes and their products and bananas.

The draft amendment to Decree No 397/2021 on requirements for preserved fruit and preserved vegetables, nuts, mushrooms, potatoes and their products and bananas is submitted in connection with the transposition of Directive (EU) 2024/1438 of the European Parliament and of the Council of 14 May 2024 amending Council Directives 2001/110/EC relating to honey, 2001/112/EC relating to fruit juices and certain similar products intended for human consumption, 2001/113/EC relating to fruit jams, jellies and marmalades and sweetened chestnut purée intended for human consumption, and 2001/114/EC relating to certain partly or wholly dehydrated preserved milk for human consumption. The main part of the amendment concerns the implementation of the requirements under the Directive, the need for certain additional partial changes, and the clarification of the existing legislation prompted by practical experience.
