5. Lubricants for four-stroke internal combustion engines – Specifications, requirements and test methods.

6. Lubricants for four-stroke internal combustion engines

This Decision concerns specifications, requirements and test methods for lubricants for four-stroke internal combustion engines intended to be used for the lubrication of petrol engines and diesel engines of four-stroke internal combustion engines (hereinafter ICE) of various types of vehicles such as two-wheel vehicles, passenger cars, buses, lorries, off-road, etc., as well as outboard motors, which operate under light, medium to heavy conditions in a wide range of ambient temperatures.

9. 1. The Directorate for Energy, Industrial and Chemical Products (DEICP) of the General Chemical State Laboratory (GCSL), in the exercise of its powers, recommends the adoption of specifications of requirements and test methods for lubricants for four-stroke internal combustion engines.

2. The previous Supreme Chemical Council (SCC) Decision "Requirements, circulation conditions and control methods for internal combustion engine lubricants" (SCC Decision 526/2004) has been adopted a long time ago.

3. It is necessary to replace the previous Decision in order to adapt it to technical progress by adding new systems for determining lubricant quality levels.

4. For the above reasons, the DEICP recommended the adoption of a draft SCC Decision which will be put out for public consultation in accordance with Presidential Decree 81/2018 (Directive (EU) 2015/1535) for a period of three months and after the assessment of any comments/remarks, it will return to the SCC, in order for the draft Ministerial Decision to be adopted, which will also be co-signed by the Ministry of Development.
