The draft Regulation is issued on the basis of the power conferred under Article 26(2) of the Act of 25 August 2006 on the system for monitoring and controlling fuel quality (Journal of Laws of 2024, items 1209, 1940 and 1946 and of 2025, item 303), pursuant to which the Minister responsible for the management of energy raw materials shall determine methods for testing the quality of liquid biofuels, taking into account the methods specified in the relevant standards in this regard.

The Regulation lays down methods for testing the quality of liquid biofuels used for transportation.

9. The draft Regulation adapts the methods for testing the quality of B100, B20 and E85 to the standards currently in force and specifies methods for testing the quality of a new liquid biofuel, i.e. liquid bio-hydrocarbons, constituting an intrinsic fuel and paraffinic diesel, hereinafter referred to as 'paraffinic bio-hydrocarbons'. Issuing the proposed regulation is necessary in order to include paraffinic bio-hydrocarbons in full quality control of fuels carried out by the Trade Inspectorate. The quality requirements for B100, B20, E85 and paraffin bio-hydrocarbons are laid down in the Regulation of the Minister for Industry and the Minister for Climate and the Environment of 21 March 2025 on quality requirements for liquid biofuels (Journal of Laws, item 426), notified under No 2024/0616/PL.
