5. The following guidelines have been established to assist in the effective implementation of radio media services that cater to the general interest on devices installed in vehicles.

8. The notified document is Annex B to the draft measure, which is currently under national public consultation.

Annex A to the draft measure consists of an update of the measures set out in the draft technical regulation already notified (Notification 2023/205/I) and adopted by Resolution No. 390/24/CONS, in the scope of which no information society services are included and, therefore, does not need to be notified again.

Annex B to the draft measure that is the subject of this notification (Resolution No. 110/25/CONS) submits for national consultation the definition of prominence measures for radio services used on devices installed in vehicles.

The measure takes into account the comments and detailed opinion issued by the European Commission in the context of notification 2023/205/I.

The mutual recognition clause is ensured by the national transpositions of Directives 2000/31/EC and (EU) 2018/1808.

9. Audiovisual and radio media services of general interest shall be given adequate prominence with the aim of ensuring pluralism, freedom of expression, cultural diversity and effectiveness of information to the widest possible audience.

Bearing in mind the constantly evolving technological and market environments in which content positioning is becoming increasingly strategic, the consultation measure is intended to ensure that certain services and content are brought immediately to users' attention, while ensuring they continue to have the widest possible choice.
