5. Order regulating the operation of the facilities of the Guiana Space Centre

6. Operation of the facilities of the Guiana Space Centre

8. This text constitutes the specific regulation applicable to the operation of the facilities of the Guiana Space Centre. As such, it provides for a general safeguard mission consisting of controlling the technical risks associated with the preparation and implementation of launches from the Guiana Space Centre in order to ensure the protection of people, property, public health and the environment, on the ground and in flight.

9. Technical developments related to the launch activities require an update of this text. The major amendments are intended to simplify and clarify the specifications based on feedback from their application, moving towards major compliance of operational and developing systems, including new technologies, taking into account the possible evolution of certain ground and on-board systems, implementing a more probabilistic approach in risk management.
