Having regard to Directive (EU) 2015/1535 of the European Parliament and of the Council of 9 September 2015 laying down a procedure for the provision of information in the field of technical regulations and of rules on Information Society services;

Having regard to the Transport Code, in particular Articles L1513-1, L1513-2 and L1513-4 thereof;

Hereby orders:

Article 1

Events or circumstances covered by the minimum universal traffic information service related to road safety referred to in Article 3 of Delegated Regulation (EU) No 886/2013 and Article D1513-4 of the Transport Code include the following categories:

- Person on the road;
- Intervention personnel for road operations or emergency services, stopped or in slow traffic on the carriageway or its appurtenances;
- Unsecured accident zone;
- Short-term road works;
- Obstruction of an unsecured road;
- Obstacle on the road;
- Debris on the road;
- Driver driving on the wrong side;
- Exceptional weather conditions affecting road holding or visibility: temporarily slippery road or reduced visibility;
- Animal on the road.

Article 2

The Director-General of Infrastructure, Transport and Mobility and the Delegate for Road Safety shall be responsible, each within the scope of their respective competences, for the

implementation of this Order, which shall be published in the *Official Journal* of the French Republic.
