5. Ministerial Decree updating the List of synthetic fertilisers subject to the payment of the 2% contribution, under paragraph 1 of Article 59 of Law No. 488 of 23 December 1999, concerning the development of

organic farming and [...]

6. The notified draft Decree applies to synthetic fertilisers, which will be subject to a 2% contribution of the previous year's turnover.

8. The draft consists of 4 articles and 1 annex.

Article 1 states that the synthetic fertilisers subject to the 2% payment referred to in Article 59(1) of Law No. 488 of 23 December 1999 are those listed in Annex 1.

Article 2 provides that where the fertiliser product placed on the market consists of one or more of the fertilisers listed in the annex to this decree for only a fraction, the contribution shall be paid in proportion to the quantity of these fertilisers present in the product.

Article 3 stipulates that the payment of the annual contribution provided for in Article 59 of Law No. 488 of 23 December 1999, as amended by Article 9 of Law No. 23 of 9 March 2022, shall take place in the manner set out in the Decree of 23 June 2023.

Article 4 provides that, as of the date of entry into force of this decree, the Ministerial Decree of 22 February 2007 is repealed.

Annex 1: lists the fertilisers subject to the levy that are placed on the national market by the legislative decree 75/2010 and regulation (EU) 2019/1009 as amended.

The objectives of the project are to respond to the need to update the list of synthetic fertilisers subject to the payment of the 2% contribution to the regulatory progress on the placing on the market of fertiliser products, as per national legislative decree 75/2010 and European regulation (EU) 2019/1009
