5. Infringements of the provisions concerning the designations of milk and milk products

6. food and feed consisting of, isolated from or produced from cell cultures or tissues derived from vertebrate animals.

This legislative proposal aims to combat the growing misuse of the designations of milk and milk products for products made from plant-based ingredients or for those in which dairy ingredients are wholly or partially replaced by ingredients of different origin. The provision consists of a single article divided into two paragraphs. The first paragraph sets out the objectives, specifies the types of punishable conduct and lays down the applicable penalties, including their severity, the detailed rules governing their application, and any ancillary penalties. The second paragraph explicitly stipulates that no reduced payment is permitted.

9. To date, this growing phenomenon has not been effectively addressed in Italy due to the absence of specific provisions on penalties establishing penalties for infringements of the relevant rules under Regulation (EU) No 1308/2013. This contrasts with the measures already implemented to address non-compliance with other provisions of the regulation, including, for example, those relating to wine products. Such conduct is misleading to consumers, creates confusion between different categories of food products, and ultimately distorts the proper functioning of the market.
