The draft decree is legislation implementing Act No 110/1997 on foodstuffs and tobacco products and amending certain related acts, as amended, and will amend existing Decree No 69/2016 on requirements for meat, meat products, fishery and aquaculture products and products thereof, eggs and products thereof

The draft decree stipulates statutory names for the provision of information on meat and unifies the method of its labelling in the context of meat cuts for meat from farm animals and game and, for example, the names of technological parts of meat. It also regulates the definitions of certain meat products and the requirements for their production. The list of commercial designations and scientific names of fishery and aquaculture products is amended.

The main reason for submission is the adaptation of existing Decree No 69/2016, and the modifications are proposed mainly on the basis of technological developments in the food industry and the application of directly applicable European Union regulations. The necessity of the proposed legislation is based on experience gained in the practical application of Decree No 69/2016.

In the Decree, for example, statutory names are defined in the area of meat and meat products, definitions and technological requirements for meat products are amended, and some qualitative requirements for selected traditional meat products are clarified. The aim of these amendments is, in particular, to protect consumers and to improve their knowledge.

The mutual recognition clause in the area of food legislation in accordance with the legislative rules in the Czech Republic is laid down in Act No 110/1997 on foodstuffs and tobacco products and thus also applies to its implementing decrees, including this draft decree.
