6. 3-methyl-alpha-PiHP (3'-Me-alpha-PiHP), pyrofenidone, 2-chloromethcathinone (2-CMC), spiroldorphine (R-6890) and ADB-4en-5Br-PINACA (ADMB-4en-5Br-PINACA).

8. On the basis of the attached classification document, the Swedish Public Health Agency proposes that the substances 3-methyl-alpha-PiHP (3'-Me-alpha-PiHP), pyrofenidone, 2-chloromethcathinone (2-CMC),

spiroidorphine (R-6890) and ADB-4en-5Br-PINACA (ADMB-4en-5Br-PINACA) be classified as narcotic drugs under the Narcotic Drugs Control Act (1992:860), and the Narcotic Drugs Act (1968: 64), and shall be included in the Ordinance on the control of narcotic drugs.

3-methyl-alpha-PiHP (3 '-Me-alpha-PiHP), pyrofenidone, 2-chloromethcainone (2-CMC) are proposed to belong to the central stimulant group. Spirochlorfin (R-6890) is proposed to belong to the analgesics group. ADB-4en-5Br-PINACA (ADMB-4en-5Br-PINACA) is proposed to belong to the hallucinogens group. For all the substances, there is scientific documentation supporting the narcotics criteria. The majority of the substances have been identified in Sweden. Most of the substances are being or have been sold through online outlets and physical stores and have been discussed on drug forums on the internet.

Classification will mean, inter alia, that the substance may not be imported or held in possession without special permission from the Swedish Medical Products Agency or the Swedish Public Health Agency.

Please note that only the substances listed next to a vertical line in the left margin of the draft Ordinance are additions to the attached ordinances. Other substances are already listed therein.

9. Given the danger posed to human health, the aim of the classification is to restrict the use of the substances listed in the Ordinances.

12. Risks to human life and health, and to public safety, mean that the regulatory amendments regarding the substance to be classified as a narcotic drug should be drawn up within a very short time frame.
