Order of 18 June 2025

amending the Order of 14 December 2023 laying down the list of versions of electric passenger cars that have achieved the minimum environmental score required to be eligible for certain financial assistance for the purchase or leasing of low-emission vehicles

Parties concerned: purchasers and leasers of vehicles; automotive professionals.

Subject: update of the list of versions of electric passenger cars that have reached the minimum environmental score referred to in Article D251-1 of the Energy Code, laid down by the Order of 14 December 2023, which are therefore eligible for certain grants for the purchase or leasing of low-emission vehicles under this criterion.

Entry into force: this Order shall enter into force on the day after its publication.

Having regard to the Energy Code, in particular Articles D251-1 to D251-13 thereof;

Having regard to the Order of 14 December 2023, as amended, laying down the list of versions of electric passenger cars that have achieved the minimum environmental score required to be eligible for certain financial assistance for the purchase or leasing of low-emission vehicles;

Having regard to the Order of 23 January 2025 amending the Order of 7 October 2023 on the methodology for calculating the environmental score and the minimum score value to be achieved for eligibility for the environmental bonus for new electric passenger cars;

Having regard to notification No 2025/X/FR addressed to the European Commission on 18 June 2025,

Hereby order:
