Annex 2.18.1 to the subsidy module may contain de facto technical requirements. The original module was therefore notified in 2022 under number 2022/0707/NL. In connection with a process step added to the table in the Annex, the present amending regulation is also being notified.

Pursuant to Article 2.18.2 of the subsidy module, a subsidy may be granted for the establishment or refurbishment of a high-grade manure processing plant. Annex 2.18.1 provides an overview of the different process steps that must be complied with in order for a high-grade manure processing plant to be eligible for a subsidy under the subsidy module. With this amendment regulation, a process step, eligible for subsidy, is added to two processes: the thickening of mineral concentrate.

A provision on mutual recognition has not been included because it is not relevant here.

9. The objective of this subsidy scheme is to increase high-grade manure processing capacity and thereby stimulate the production of high-grade fertilisers (fertiliser substitutes) from animal fertilisers, so that the use of conventional fertilisers can be replaced by the use of high-grade processed animal fertilisers.

The additional process step included in the amending regulation in Annex 2.18.1, which makes it possible for two additional processes to qualify as high-grade manure treatment plants under this subsidy module, is non-discriminatory and also suitable and necessary to achieve the objectives. This means: to actually produce a final product that can be used as a fertiliser substitute, to actually stimulate high-grade manure processing in a manner consistent with future manure policy and also to contribute in this way to the protection of the environment. This process step ensures that less storage capacity and transport movements are required, and the product can be used in a more concentrated form. The requirements for the processes are proportional and do not go beyond what is necessary to achieve the aforementioned objectives. In this context it is important to note that different processes can still be chosen from to create a high-grade manure processing plant and therefore an eligible investment project. Finally, a subsidy scheme is the least restrictive means of achieving the aforementioned objectives.
