The draft law aims to amend the Law of 8 September 2022 establishing the Luxembourg Veterinary and Food Administration (ALVA) in order to take into account Opinions Nos 61.359, 61.419 and 61.628 of the Council of State on future sectoral laws relating to official controls on foodstuffs, animal feed and animal health.

9. This draft law is intended to amend the Law of 8 September 2022 establishing the Luxembourg Veterinary and Food Administration (ALVA) following Opinions Nos 61.359, 61.419 and 61.628 of the Council of State on future sectoral laws relating to official controls on foodstuffs, animal feed and animal health.

These opinions include a parallel remark concerning designation of the competent authority. Indeed, the division of responsibilities between ALVA and the Minister lacks clarity throughout the texts. It is therefore necessary to amend Article 2 of the above-mentioned Law of 8 September 2022 in order to clarify the respective responsibilities of ALVA and the Minister, while complying with the provisions of the European regulations governing these matters. In the interests of consistency, the above-mentioned draft laws are also being amended in parallel with this draft law.

In addition, this text provides for the addition of a new power to the current list of ALVA powers, which concerns the performance of certain administrative tasks within the scope of its authority, provided for in Regulation (EU) 2023/1115 of the European Parliament and of the Council of 31 May 2023 on the making available on the Union market and the export from the Union of certain commodities and products associated with deforestation and forest degradation and repealing Regulation (EU) No 995/2010.
