According to the bill, an adult natural person residing in the Republic of Slovenia will be able to grow up to four cannabis plants for personal use and possess up to 7 grams of dried inflorescences of the cannabis plant in public areas and up to 150 grams of dried inflorescences of the cannabis plant for limited personal use at the address of permanent residence and up to 5 grams or 5 millilitres of resin, extracts and other preparations from the cannabis plant in public areas and up to 50 grams or millilitres of resin, extracts and other preparations from the cannabis plant for limited personal use at the address of permanent residence. Up to 100 grams or millilitres of resin, extracts and other preparations may be possessed in each housing unit, regardless of the number of adult members of the household. However, if several individuals cultivate cannabis in a household or in a housing unit, the number of plants will be limited to six. In addition, the person will also have to ensure that measures are in place to prevent access to cannabis for limited personal use and to prevent its use by persons under 18 years of age. A natural person will be able to give away to another person, free of charge, the permitted quantities per person. The Act also lays down the permissible THC content when testing drivers in road traffic. For testing, the limit is set at three nanograms of THC per milligram of blood. Drivers who do not show psychomotor impairment at this content will not be penalised. Otherwise, the penalty will be EUR 300, and drivers will receive another four penalty points. For 3-5 ng of THC/ml of blood, the penalty will be EUR 600 and eight penalty points. For THC content above 5 ng/ml of blood, they propose a penalty of EUR 1,200 and 18 penalty points. The Act also introduces a prohibition for employers to test the THC content of employees in the context of regular employee health checks. The Act also introduces preventive measures where access by minors to cannabis plants is prohibited, smoking is also prohibited in the vicinity of minors and in the vicinity of educational institutions.

9. The aim of the Act is to ensure that the inhabitants of the Republic of Slovenia have access to cannabis for limited personal use, thereby reducing the illegal production and trafficking of cannabis of untested quality, which may contain toxic adulterants, contaminants and synthetic cannabinoids that are harmful to health (from the text of the Act).

In accordance with the principle of integrity, the bill regulates the cultivation and possession of cannabis (*Cannabis sativa* L.) for limited personal use, produced by an individual in limited permitted quantities for personal use, control mechanisms and authorities with competence, and preventive measures related to the use of cannabis with a THC content above 1 % (from the text of the Act).
