5. Regulation of Good Distribution Practices for Cosmetic Products. It defines the principles and standards of good distribution practices for cosmetic products.

8. The proposed Regulation defines the principles and standards of good distribution practices for cosmetic products.

The provisions of this proposal shall apply to entities distributing cosmetic products in Portugal or to Portugal from another Member State, with the necessary adaptations.

9. With the publication of Decree-Law No 23/2025 of 19 March 2025, the implementation in national law of Regulation (EC) No 1223/2009 of the European Parliament and of the Council of 30 November 2009 (hereinafter Regulation (EC) No 1223/2009) laying down the rules with which cosmetic products available on the market must comply in order to ensure the functioning of the internal market and a high level of protection of human health was ensured.

This Decree-Law also establishes the obligation of registration of activity for economic operators who manufacture, import or carry out the first sale in the context of the distribution of cosmetic products in Portugal, and also includes provisions for the establishment and functioning of economic operators that operate in the cosmetic products sector.

Taking into account that the distribution phase is fundamental within the integrated supply system of cosmetic products, and taking into account the need to ensure the quality and safety of these products throughout the entire marketing chain on the national market, it is therefore important to implement the good distribution practices for cosmetic products which must be complied with by distributors operating in the wholesale trade, as well as by retailers.
