8. The interface description (SSB) regulates the basic requirements for weather probes in the weather aid radio service in accordance with Section 4(2) of the Act on the Provision of Radio Equipment on the Market (Radio Equipment Act - FuAG).

This interface specification replaces SSB SF 004, January 2017 edition, notified under No 2017/0235/D.

9. The interface specification serves to ensure both that the radio spectrum is used effectively and that there is support for the efficient use of radio frequencies, so that no radio interference occurs. The interface specification is specified pursuant to Directive 2014/53/EU.
