This national complementary regime ensures that even those vehicle parts (plastic glazing) that are not covered by EU requirements are nevertheless safe and eligible for approval. It thus creates legal certainty for manufacturers, testing organisations and vehicle owners—in particular in the field of special vehicles and individual modifications.
