5. Decree amending Decree No 248/2018 on the requirements for beverages, brewed vinegar and yeast.

8. The draft Decree is implementing legislation to Act No 110/1997 on foodstuffs and tobacco products and on amendments to certain related acts, as amended, and will amend the existing Decree No 248/2018 on the requirements for beverages, brewed vinegar and yeast.

The draft Decree lays down the legal names and the requirements for quality and for the provision of information on non-alcoholic beverages (in particular fruit juices and nectars) and alcoholic beverages (in particular beer, fruit wines and spirits), as well as the conditions for placing brewed vinegar and yeast on the market.

The main reason for the submission is to adapt the existing Decree No 248/2018 to scientific knowledge and technological developments in the food industry and to implement directly applicable European Union legislation. The need for the proposed legislation arises from experience gained in the practical application of Decree No 248/2018, which has not yet been amended.

For example, the Decree defines the legal names relating to beverages, lays down definitions and technological requirements for beverages, and refines certain quality requirements for selected alcoholic and non-alcoholic beverages. The main objective of these amendments is the protection of consumers and the improvement of their awareness.

The mutual recognition clause in the area of food legislation in accordance with the legislative rules in the Czech Republic is laid down in Act No 110/1997 on foodstuffs and tobacco products and thus also applies to its implementing decrees, including this draft decree.
