5. Order on subsidies for individual heat pumps for the scrapping of oil, wood pellet or gas boilers

6. Products and materials that will be included in the carrying out of projects in which heat pumps are installed at one or more heating customers in exchange for the scrapping of their oil, wood pellet or gas boiler outside of areas

8. Products and/or services concerned:

Products and materials that will be included in the carrying out of projects in which heat pumps are installed at one or more heating customers in exchange for the scrapping of their oil, wood pellet or gas boiler outside areas designated for district heating.

The order applies to subsidies for the implementation of projects for the conversion of heating systems in buildings for year-round residence in order to achieve energy savings and energy efficiency improvements as well as reductions in the use of fossil fuels in connection with this.

Subsidies may be awarded through the subsidy scheme upon application by private building owners and companies. The projects eligible for subsidies are limited to measures concerning the conversion of the heat source of buildings to a heat pump.

This order applies to subsidies for companies carrying out projects with heating customers aimed at energy savings and energy efficiency improvements. Subsidy commitments are awarded to pre-qualified energy service providers for projects in which a heat pump is installed at one or more heating customers in exchange for the scrapping of their oil, wood pellet or gas boiler outside areas designated for district heating.

The Danish Energy Agency can grant a subsidy to partially cover the costs of the energy service provider for the purchase of a heat pump providing heat for individual heating in buildings that is installed at a heating customer whose oil, wood pellet or gas boiler is scrapped and replaced by a heat pump. The energy service supplier purchases the heat pump to use in a subscription arrangement, under which the energy service supplier takes ownership and offers installation, operation and maintenance of the heat pump, as well as the supply of the heat to the heating customer, charging by ongoing invoicing.

9. The assessment by the Danish Energy Agency is that the scheme contains technical regulations as defined in the Directive, as it stipulates both characteristics of products that will be eligible for subsidies (technical specifications) and requirements regarding the use of products, which will have a significant impact on sales of the products (second requirement) (see Article 1(1)(c) and (d)).

In the assessment, emphasis has been placed on the fact that subsidies through the scheme for conversion to heat pumps are limited to heat pumps that have a better energy efficiency than the minimum standard.

Since the regulation constitutes a financial incentive (subsidy), it is the Danish Energy Agency's assessment that there is only actual compliance (as opposed to legal compliance where there is a requirement relating to the marketing or use of the products concerned). In the opinion of the Danish Energy Agency, this means that the exemption from the requirement for a standstill period applies, which in turn means that, following

notification, there is no requirement to postpone entry into force of the order.
