5. Ministerial Decree establishing the standard procedure for the exploratory soil investigation under the Soil

Decree of 27 October 2006

6. Conducting an exploratory soil investigation. An exploratory soil survey aims to determine whether there are clear indications of the presence of soil contamination on a site.

The Soil Decree of 27 October 2006 (Article 28(2)) provides that an exploratory soil survey is to be carried out under the direction of a soil remediation expert, in accordance with the standard procedure laid down by the Flemish Government on a proposal from the OVAM. A report of the preliminary soil investigation is drawn up and submitted to the OVAM by the soil remediation expert in accordance with the aforementioned standard procedure. In Article 7 of the

VLAREBO Decree of 14 December 2007, the Flemish Government delegated the adoption of the standard procedure for exploratory soil examination to the Flemish Environment Minister. The Ministerial Decree notified by this notification establishes the above-mentioned standard procedure.

The standard procedure for exploratory soil investigation further specifies the procedure for conducting an exploratory soil investigation on the basis of binding, guiding and advisory elements on the implementation (including preliminary study, sampling strategy, interpretation and evaluation of the analysis results, and assessment) and the reporting and data transfer.

9. The notified Ministerial Decree with the established standard procedure aims to ensure the qualitative performance of an exploratory soil survey led by accredited soil remediation experts, and thus to ensure that contaminated soils requiring further soil testing are identified and thereby also contribute to the protection of human health and the environment.
