5. Ministerial decree approving the special technical provisions to the decree of the Flemish government of (...) regulating safety measures in the establishment and operation of natural gas distribution facilities and operations

6. Natural gas

8. This ministerial decree contains the technical measures necessary to guarantee the safety of natural gas distribution within Flanders. These measures are aimed at both distribution system operators with regard to the design, construction, commissioning, operation and maintenance of natural gas distribution facilities and third parties that carry out work on or near natural gas distribution facilities. This ministerial decree contains the specific technical provisions referred to in Article 76 of the draft decree of the Flemish government regulating safety measures for the construction and operation of natural gas distribution installations and for work near such installations.

9. Natural gas distribution, the supply of natural gas to final consumers is a regional competence based on Article 6(1)(VII)(1)(b) of the Special Act on Institutional Reform (BWHI). Until recently, the control of natural gas distribution safety was regulated on the federal level. This changed in 2021, when the Council of State, in its Opinion 70.190/VR on the draft Royal Decree on the safety measures to be taken in connection with the establishment and operation of pipeline gas distribution facilities and to be respected by third parties in connection with works in the vicinity, ruled that natural gas distribution security falls within the competence for energy policy as referred to in Article 6(1)(VII)(1)(b) of the BWHI and that the 'regulation relating to remedial measures concerning the facilities supporting the network activity of gas distribution must be regarded as falling within the competence of the regions'. Consequently, the Council of State asserts in this opinion that control of the safety of the distribution of natural gas is a regional competence.

As a result of this clarification of the division of competences between the federal and regional levels, a new article was added to the Energy Decree of 8 May, 2009: Article 4.1.11/8. This article requires that the Flemish government, acting on a joint proposal from the natural gas distribution system operators, adopt a safety code. This safety code defines the technical measures necessary to ensure the safety of the natural gas distribution network.

As mentioned earlier, this ministerial decree contains the technical measures referred to in the safety code.
