

Government Decree

amending the Government Decree on the Implementation of the Alcohol Act

By decision of the Government,
section 1(2) and (3) of the Government Decree on the Implementation of the Alcohol Act (151/2018) are *repealed*;
introduction of section 1(1), section 6(1)(4) and (2)(5), section 7(1)(3) and introduction of section 9(1), introduction of section 10(1), introduction of section 12, and section 13 are *amended*; and
a new paragraph 5 shall be *added* to section 6(1) and a paragraph 6 shall be added to sub-section 2, a new section 6a shall be added to the act, and a new paragraph 4 shall be added to section 7(1) as follows:

Section 1

General content of the application

The licence application referred to in section 8 of the Alcohol Act (1102/2017) shall be submitted on a form established by the Finnish Supervisory Agency and shall contain:

Section 6

Content of the application for a retail licence for alcoholic beverages

The application for a retail licence for alcoholic beverages referred to in section 17(1) of the Alcohol Act shall contain:

4) the location of the mobile shop van or boat and a description and map of the planned route with schedules;

5) if necessary, the location and contact details of the pick-up point of the retail outlet referred to in section 17(5) of the Alcohol Act.

An application for a retail licence for country wine or artisanal beer referred to in section 17(2) of the Alcohol Act shall contain:

5) a description of the cash register and sales arrangements for the retail sale of alcoholic beverages;

6) where applicable, the location and contact details of the pick-up point of the retail outlet referred to in section 17(5) of the Alcohol Act.

Section 6a

Content of the application for a supply licence of alcoholic beverages

The application for a supply licence referred to in section 17a of the Alcohol Act must include:

1) the location and contact details of the applicant's place of business or, if there is no place of business, the applicant's domicile;

2) the report referred to in section 17a(1)(2) of the Alcohol Act.

The licensing authority may require the applicant to provide additional information necessary to ensure supervision or safety in order to assess the necessity of the conditions and restrictions referred to in section 17a(2) of the Alcohol Act.

Section 7

Content of applications by alcohol companies

The application referred to in section 26(1) and section 28(1) of the Alcohol Act shall contain:

3) in the case of a mobile shop van and boat, the contact details of the place of business and a description and map of the planned route with schedules;

4) where applicable, the location and contact details of the pick-up point referred to in section 26(1) of the Alcohol Act.

Section 9

Contents of the extended hours notification and extended hours application

The extended hours notification referred to in section 44(1) of the Alcohol Act and the extended hours application referred to in sub-section 2 shall be made on a form established by the Finnish Supervisory Agency and shall contain:

Application for approval of a facility or area as licensed premises

The application referred to in section 20(1) of the Alcohol Act shall be made on a form established by the Finnish Supervisory Agency and shall contain:

Section 12

Notification of the event

The notification referred to in section 20(2) of the Alcohol Act shall be made on a form approved by the Finnish Supervisory Agency and shall contain:

Section 13

Application or notification of a change of activity

The application for amendment of the licence and approvals referred to in section 11 of the Alcohol Act and the notification of changes shall contain:

- 1) information on the planned date of the implementation of the change;
- 2) a description of the activity to be modified and, for the modified activity, the same information as in the application or notification;
- 3) an updated self-supervision plan referred to in section 56 of the Alcohol Act, if this is a prerequisite for the licence or if the self-supervision plan must be attached to the notification.

The licensing authority may require any additional information necessary to assess the conditions for granting or approving the licence and the necessity of the terms, conditions and restrictions attached to the licence or approval. For that purpose, a description may also be required in respect of the activities connected with the change which remain unchanged.
