5. Regulation on the Salzburg Provincial Government on Animal Breeding in the Province of Salzburg (Salzburg Animal Breeding Regulation 2025 – S.TZV 2025)6. The key concern is the adoption of implementing provisions in the field of breeding, trade in purebred breeding animals and hybrid breeding pigs

and their breeding material, as well as insemination. 7. Directive 2006/123/EC on services in the internal market Requirements which reserve access to particular providers The aim is to ensure the provision of qualified uniform vocational training. Yes, in order to ensure that only technically suitable and reliable persons work in this field. Yes 8. The Salzburg Animal Breeding Law is intended to ensure the implementation of directly applicable, and the transposition of non-directly applicable, legal acts of the European Union in the field of animal breeding. At a legislative level, this is done by the S.TZG 2021, which enshrines the most important requirements of Union law in national law. With the S.TZV 2025, those areas that could not be regulated in sufficient detail in the law are now to be further specified at a regulatory level. The aim is to facilitate the interpretation and application of the requirements for the addressees of the standard and the authority. More specifically, the purpose of the Regulation is to regulate the areas referred to in Section 22 of the S.TZG 2021 to the extent that this is deemed necessary. Section 1 Paragraph 1 sets out this general objective of the S.TZV 2025. 9. The Salzburg Animal Breeding Act 2021 – S.TZG 2021, Provincial Law Gazette No 63/2021, has already aligned animal breeding law at state level with the requirements of EU law. Now the implementing regulatory law is also to be updated accordingly by enacting the Salzburg Animal Breeding Regulation 2025 – S.TZV 2025. This is intended to help achieve the objectives set out in Regulation (EU) 2016/1012 and in S.TZG 2021 and to ensure the effective implementation of animal breeding legislation. According to the S.TZG 2021, it is possible for foreign breeding associations or breeding operations, insemination technicians, and on-farm insemination specialists to work domestically. In order for the authority (Section 19(1) S.TZG 2021) to quickly obtain an overview of the content of applications submitted, paragraph 2 provides that, in the case of documents drawn up in a foreign language, they must also be submitted in a German translation.
