5. Government Decree amending the Government Decree on narcotic substances, preparations and plants

One new substance, cychlorphine, is classified nationally as a narcotic.

6. Cychlorphine

8. Finland intends to define these substances as narcotic drugs in accordance with the Narcotics Act (373/2008); as a result, the manufacture, import, export, sale or possession of the substances without a separate permit from the Finnish Medicines Agency Fimea will be prohibited.

9. The substance is a synthetic opioid belonging to the piperidine-benzimidazolone group, which belongs to the opioids group. The substances have significant potential for abuse and addiction. Opioids are dangerous because of their effects on the central nervous system, the most severe of which is dose-dependent respiratory depression. Some of these substances may have an effect at very low doses, even lower doses than the potent fentanyl. Not only does this make these substances particularly dangerous, but it is also difficult to determine the appropriate dosage and to administer them correctly. The substances are also marketed in such a way that there is no certainty about the content or purity of the product sold, or they are sold as completely different products or substances. This also leads to unintended life and health-threatening situations.

Criminal groups are constantly trying to find new substances that are outside the scope of current legislation. Therefore, these identified substances, which are used as designer drugs and have been observed on the European markets and may pose a health hazard, must be swiftly prohibited by a government decree.

12. Protection of public health. The substances must be classified as narcotics because there is an existing user base, and harms and even deaths have already been observed in Finland. The aim of swift prohibition is to prevent the harms caused by the increased abuse of these dangerous substances.
