The product specification of the High Quality Food (KMÉ) national quality scheme for live fish and fresh and prepared fishery products previously notified under No 2022/842/HU is replaced by the notified draft. Under the heading “Optional elements” in the Specific Certification Requirements, more precisely under sub-heading “II. Sustainability”, new points have been formulated for sustainability, significantly expanding the range of optional elements.

The addition of further product specifications to the High Quality Food (KMÉ) quality scheme is intended to enable the indication of higher quality for the widest possible range of food products in order to properly serve customer needs and to enable producers to join the quality scheme with a variety of products.
